

> "2) The proponent of a development shall be financially responsible for any damages caused by the applicant, their servants, suppliers, agents or contractors to any public or private property resulting directly or indirectly from development on a lot."

C. That Section 3.13 is further amended by inserting the following new provision as subsection (3) and renumbering the rest of the section as required:

"3) Further, the proponent of a development shall also be responsible for all costs associated with providing and/or improving on and off-site municipal services (water, 13.1 Town of Smoky Lake's Land Use Bylaw 007-18 Request for Decision

wastewater, stormwater, driveway connections, roadways and sidewalks), as well as all franchise utilities required to service to the site."

D. That Section 7.9(1) be deleted and replaced with the following:

"1) Hard Surfacing of a driveway (concrete, asphalt or other similar material) shall be provided by the development proponent; to the satisfaction of the Development Authority; at time of subdivision and/or development approval, and at no cost to the municipality, in all districts where access is gained onto a hard-surfaced public road."

E. That Section 10.4(2) be revised to delete the following use: "manufactured homes" from the list of permitted uses and replace it with the following use: "manufactured homes, no older than 10 years from date of manufacture to date of development permit issuance".


