## **CONDITIONS**

1. a) **A fire permit is valid only for the period for which it is issued.**  
  
b) **The issuing authority when issuing a fire permit may impose on the permit any special fire control conditions with which the applicant must comply in addition to the provisions of this permit.**
  
2. **A fire permit may be cancelled at any time by the issuing authority and upon receiving notice of the suspension or cancellation the person concerned shall immediately extinguish any fire set pursuant to the permit.**
  
3. **No person shall:**
  - a) **Light an outdoor fire without first taking sufficient precautions to ensure that the fire can be kept under control at all times,**
  - b) **Light an outdoor fire when weather conditions are conducive to a fire readily escaping out of control,**
  - c) **Fail to take reasonable steps to control a fire for the purpose of preventing it from spreading onto land other than his own,**
  - d) **Deposit, discard or leave any burning matter of substance in a place where it might ignite other matter and result in a fire,**
  - e) **No person shall burn materials which are illegal to burn (ie: Tires, asphalt shingles, etc.)**
  
4. **Every person who sets a fire under authority of a permit shall:**
  - a) **Keep the permit at the site of the fire**
  - b) **Produce and show the permit to the Fire Chief or acting Fire Chief upon request.**
  - c) **Keep the fire under control**
  - d) **Extinguish the fire before expiration of the permit or upon cancellation of the permit.**
