A BYLAW OF THE MUNICIPALITY OF THE TOWN OF SMOKY LAKE IN THE PROVINCE OF ALBERTA, TO AMEND PROCEDURAL BYLAW 014-19 BEING THE ORGANIZATIONAL AND PROCEDURAL BYLAW FOR THE TOWN OF SMOKY LAKE.

**WHEREAS** the Municipal Government Act, R.S.A. 2000, and amendments thereto, authorizes the Council for the Town of Smoky Lake to amend the Procedural Bylaw, and

**WHEREAS** the Council for the Town of Smoky Lake has adopted Town of Smoky Lake Bylaw 014-19 to be used as the Procedural Bylaw, and

**NOW THEREFORE**, the Council of the Town of Smoky Lake, duly assembled, enacts as follows:

**CONDUCT OF MEETINGS (GENERAL)**

- 6.1 Council meetings shall be held in the Council Chambers at the Town of Smoky Lake Office and/or through **Electronic Communication Technology (web-based and/or telephone platforms)**. **Electronic meeting participation and public observation gives flexibility to Council and municipal staff to conduct business using telephone and/or video conferencing without compromising the rights of the public to attend and observe meetings of Council or Committees established by Council.**


**SEVERABILITY CLAUSE**






