TOWN OF SMOKY LAKE IN THE PROVINCE OF ALBERTA BYLAW NO. 015-10

Being a Bylaw of Town of Smoky Lake in the Province of Alberta to establish and enter into agreement to provide an **EMERGENCY 9-1-1 FIRE DISPATCH SERVICE.**

WHEREAS, pursuant to the provisions of the *Municipal Government Act*, Chapter M-26, Revised Statutes of Alberta 2000, and amendments thereto, the Municipal Council of Town of Smoky Lake may pass a Bylaw respecting the safety, health, and welfare of people and the protection of people and property.

AND WHEREAS, pursuant to the provisions of the *Municipal Government Act*, Chapter M-26, Revised Statutes of Alberta 2000, and amendments thereto, the Municipal Council of Smoky Lake as a municipality may provide any service or thing that it provides in all or part of the municipality in another municipality authority with the agreement with the other municipal authority.

AND WHEREAS, the Council of Town of Smoky Lake wishes to provide Emergency 9-1-1 Fire Dispatch Service within the municipality and enter into agreement(s) with other agencies and/or municipalities to provide such services.

AND WHEREAS, the Provincial E9-1-1 Agreements executed with the Town of Smoky Lake on March 12, 1997, as referenced in Bylaw 706-97, remain in effect as follows:

- "Agreement to Provision Provincial E9-1-1 Service" with TELUS COMMUNICATIONS INC.
- 2. "Notice Pursuant to the Agreement to Collect Municipal Charges for Provincial E9-1-1 Service" with TELUS COMMUNICATION INC.
- 3. "Agreement to collect Municipal Charges for Provincial E9-1-1 Service" with TELUS COMMUNICATION INC.

AND WHEREAS, Smoky Lake County, pursuant to Bylaw No. 015-10 passed pursuant to the *Municipal Government Act*, authorized the making of an agreement with:

- Bonnyville Regional Fire Authority.
- 2. Town of Smoky Lake.
- 3. Village of Waskatenau.
- 4. Village of Vilna

to provide Emergency 9-1-1 Fire Dispatch Service on a per capita basis within the Smoky Lake County Region Municipalities.

NOW THEREFORE BE IT RESOLVED that the Council of the Town of Smoky Lake duly assembled enacts as follows:

1. That the Town of Smoky Lake enter into an agreement with **Bonnyville Regional Fire Authority** to provide Emergency 9-1-1 Service and Fire Dispatch Services on a per capita basis to the Town of Smoky Lake, effective **February 1, 2011** for:

- 1.1 Complete emergency dispatch services for the municipality.
- 1.2 Answering and processing 9-1-1 calls as a public call answer point including notification of identified first emergency responders for EMS and Fire and dispatch of support services such as power and gas for structure fires, Police and EMS support for motor vehicle incidents.
- 1.3 Record all communications from radio and telephone that originate in the centre.
- 1.4 Track all Fire Permits within the Town of Smoky Lake.
- 2. Copy of the agreement executed jointly with the Town of Smoky Lake, Village of Waskatenau, and Village of Vilna and attached to this Bylaw, forms part of this Bylaw. This joint agreement and the terms and provisions within it may, from time to time, be amended by and with the consent of all parties without being in contravention of this bylaw.
- 3. That **Bylaw No. 706-97**, is hereby repealed.
- 4. That the following Agreements remain in effect:
 - 4.1 "Agreement to Provision Provincial E9-1-1 Service" with TELUS COMMUNICATIONS INC.
 - 4.2 "Notice Pursuant to the Agreement to Collect Municipal Charges for Provincial E9-1-1 Service" with TELUS COMMUNICATION INC.
 - 4.3 "Agreement to collect Municipal Charges for Provincial E9-1-1 Service" with TELUS COMMUNICATION INC.
- This Bylaw shall come into force and effect on the final date of passing thereof.
